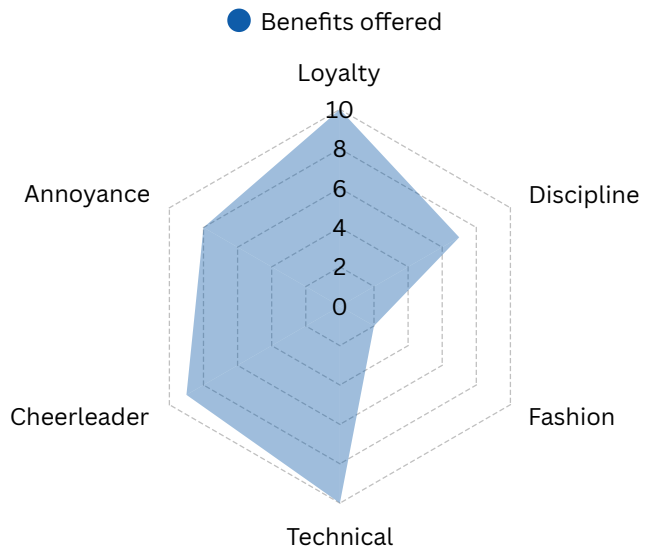
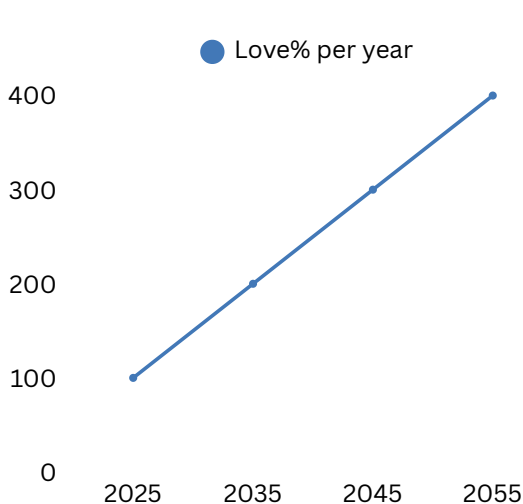
C. Transaction Overview
